

## Tour Signup Form for Colleyville Heritage High School Choir

Your Colleyville Heritage High School Choir Hawaii Tour includes:

- 1) Four-night accommodations at the Ashton Waikiki Beach Hotel or Similar
- 2) Round trip commercial jet transportation from Dallas to Hawaii to include the first piece of checked luggage
- 3) Luxury motorcoach transportation to and from the Dallas airport and while in Hawaii per itinerary (includes driver gratuity)
- 4) Meals to include Breakfast each morning at the hotel, one dinner at the Hard Rock Café, one dinner at Buca Di Bepo, one dinner at the Polynesian, and one \$20.00 dinner Stipend
- 5) Admission to the USS Missouri, and Pearl Harbor to include the ferry to the USS Arizona (pending availability)
- 6) Admission Hanauma Bay Marine Embayment
- 7) A guided tour of Ka'a'awa Valley, Diamond Head Lookout
- 8) A full day to include a Luau Dinner and show at the Polynesian Culture Center
- 9) The services of a USIT tour conductor at all times at the destination to oversee the smooth operation of the tour.

\*Pricing is based on a minimum of 55 passengers per coach and on a minimum of 55 Participants in the tour. All prices are subject to changes in airline fares, taxes, surcharges, especially fuel surcharges, and changes in vendor rates. When the airfare is finalized, adjustment to the price may be administered by the Agent. Any land-only participants must be registered with the Agent and processed 90 days or more before departure. Individuals may be liable for luggage charges, depending on the policy of the airline.

Your Colleyville Heritage High School Choir Hawaii Tour Payment Schedule:

- A. A deposit of \$294.00 per person is due upon registration
- B. Five additional payments of \$320.84.00 per person is due on the 1<sup>st</sup> of each month starting September 1, 2022
- C. A final payment of the remaining balance per person must be received no later than February 3, 2023

All payments are to be made via our online payment system, hosted by We Travel. Payments being made via check account transfer will not pay any additional fees. All Credit card payments will be charged a 2.9% fee at time of payment (American Express charges a higher fee)

Cost of Tour: The prices quoted are based on tariffs, and taxes as of May 17, 2022. In the event of a change in any of these, the right is reserved by US Integrity Touring to make increases in prices to the participant or will substitute services. US Integrity Touring reserves the right to withdraw any portion or all of any travel package to make such alterations or substitutions as necessary or desirable to maintain the safety, value and integrity of the tour. Should an element of the program become unavailable through accident, act of God, or other circumstance beyond USITs control, US Integrity Touring will make substitution of equal or superior value to the best of our abilities. Should any interruptions or cancellations occur on the flight schedule, the agent will assist the client to find the best solutions available, any additional costs will be the responsibility of the client. The price charged is based on room occupancy (single, double, triple quad) as stated on this form and constitutes the full package price.

Cancellation Policy: Cancellations and requests for refunds must be submitted in writing to your organization. All documents, including tickets of any value, must be returned to USIT before any refund may be processed. Cancellation fees are used to protect the package price of the remaining participants **Upon registration, trip insurance will be offer and we highly recommend you consider cancel for any reason insurance. As this is offered by a third party, US Integrity Touring takes no responsibility for any unpaid claims.** Cancellation charges, per person, are figured against the full package price and may be as much as shown here;

- 1) From sign up until 90 days prior to departure (December 7, 2021) = 25% of full price (\$554.75)
- 2) 61 – 89 days prior to departure (January 6, 2022) = 50% of full price (\$1,109.50)
- 3) 41 - 60 days prior to departure (January 26, 2022) – 75% of full price (\$1,664.25)
- 4) 0 - 40 days prior to departure = 100% of full price (no refund)

Participants paying late may be subject to a late fee of \$5.00 for each month or part thereof. **If an individual participant is more than 60 days behind with any payment, or late with the final payment, the Agent or the Client may remove him/her from the tour with full penalties applied as a cancellation charge on the schedule as shown above.** No refunds will be given until after the original dates of travel. If the full tour is canceled due to unsafe travel conditions or to the Agent deciding prevailing conditions are not safe enough to

conduct the tour, the cancelation penalty will be reduce to 15% of the full package price plus the cost of any items such as event tickets, airline deposits, vendor penalties, hotel deposits, or any other payments made on the clients behalf that become non-refundable prior to the cancelation date (so long as cancelation is received by the Agency from the approving authority). Should the tour not be canceled under the provisions of this paragraph, the normal penalties will apply, regardless of reason for cancelation.

Responsibility: US Integrity Touring acts only as agent in providing means of transportation, hotel, or other services. Since USIT contracts only with reputable vendors and service – providers, each is responsible for the goods and services they provide. The participant is subject to any and all terms and conditions under which services are provided by the vendors, and registration for this tour constitutes agreement by the participant that US Integrity Touring shall not be, nor become liable or responsible in any way for any loss, injury, or damage to or in respect of any person or property, including baggage, caused by or arising in connection with such means of transportation or any other services provided in fulfillment of this tour. US Integrity Touring reserves the right to decline, accept, or retain any participant as a member of this tour and shall not have responsibility to decline individuals beyond the refund of an appropriate portion of monies paid by the participant to Us Integrity Touring. It is the responsibility of each participant to behalf in a responsible and safe manor. US Integrity Touring in its sole discretion reserves the right to send home any participant, at the participant’s expense, that is disruptive of the tour or engages in any illegal activities.

Notice: passengers are limited to one suite case weighing no more than 50 lbs. and a carry of less than 25 lbs.
